Whereas, as per recommendation of the D.P.C. meeting held on 19-3-2010 as conveyed by the GPSC vide letter No. COM/II/11/15(1)/2000-01/(Vol.II)/85 dated 23-03-2010 and on acceptance of the said DPC recommendations by the Government, the following 4 (four) recommended officers were promoted on regular basis to the post in the cadre of Dy. Education Officer/Principal-GHSS/VEO/Joint Secretary (GBSHSSE) vide Order No. 1-(6)-2-2008/SE/72 dated 31-3-2010:-

- 1) Shri Damodar B. Naik.
- 2) Shri Ramrao H. Patil.
- 3) Shri Koti S. Fataroddin.
- 4) Smt. Swarupa V. Naik Gaonkar alias Swarupa Satish Dessai.

And whereas, Mrs. Susan Vaz, who was working as Headmaster of Government High School on extension in service from 01-08-2009 to 31-07-2010 beyond superannuation as per Rule 88(2) of the Goa School Education Rules, 1986 was aggrieved over the above promotion order dated 31-03-2010 and had filed at Writ Petition No. 514 of 2010 in the Hon'ble High Court of Bombay at Goa on 30-06-2010 to quash and set aside the said promotion order dated 31-03-2010 and to direct the respondent No. 1 & 2 to forward the case of the Petitioner to respondent No. 7 for promotion to the post of Deputy Education Officer/Principal-Government Higher Secondary School/Deputy Director, SIE/Vocational Education Office/Joint Secretary (GBSHSSE).

And whereas, the Hon'ble High Court of Bombay at Goa vide interim order dated 27-7-2010 had given following directions in Writ Petition No. 514 of 2010:

"If there is a vacancy available as of today, while making appointment to the said vacant

post, the case of the Petitioner will have to be considered on merits. Hence, by way of interim relief, we direct that while filling up of any post of the aforesaid vacant posts, the case of the Petitioner for the appointment to the said posts shall be considered in accordance with law".

And whereas, as on the date of passing of above interim order dated 27-07-2010 by the Hon'ble High Court of Bombay at Goa in Writ Petition No. 514/2010, one vacancy in the cadre of Deputy Education Officer/Principal, Government Higher Secondary School/Deputy Director, SIE/Vocational Education Officer/Joint Secretary (GBSHSSE) was available to be filled by promotion which had occurred on 01-03-2009 due to retirement on superannuation of Smt. Lata Sawardekar on 28-02-2009.

And whereas, Smt. Suzan Vaz, Petitioner in W.P. No. 514/2010 had retired on 31-07-2010 after expiry of extension in service of one year beyond superannuation.

And whereas, a proposal was submitted to the GPSC vide letter No. 1(6)-2-2008/SE/37 dated 07-02-2011 for filling up of vacancy dated 01-03-2009 by promotion from Smt. Cynthia Coelho by stating that she was the only eligible officer available in feeder grade in the seniority to be considered for promotion.

And whereas, the DPC in meeting held on 14-06-2011 recommended the name of Smt. Cynthia Coelho for promotion to the post of Deputy Education Officer/Principal, Government Higher Secondary School/Deputy Director, SIE on regular basis with immediate effect against the vacancy dated 01-03-2009 as conveyed by the GPSC vide letter No. COM/II/11/15(2)/2011/70 dated 16-06-2011. The said DPC recommendation was accepted by Government on 24-6-2011.

And whereas, Smt. Cynthia Coelho had retired on superannuation w.e.f. 30-09-2012 (a.n.).

And whereas, as per remarks of ex officio Joint Secretary/then Director of Education, promotion order of Smt. Cynthia Coelho was kept in abeyance, without any reason till she retired on superannuation.

And whereas, Smt. Cynthia Coelho had filed a Writ Petition bearing No. 675/2013 in the Hon'ble High Court of Bombay at Goa for grant of Notional Promotion and consequential benefits to the post of Cadre of Deputy Education Officer/Principal, Government Higher Secondary School/Deputy Director, S.I.E./Vocational Education Officer, w.e.f. the date of the recommendation of the Goa Public Service Commission.

And whereas, the Hon'ble High Court of Bombay at Goa disposed off the said Writ Petition No. 675/2013 filed by Smt. Cynthia Coelho on 18-02-2014 with the following order:-

1. The Petitioner's application for grant of notional promotion and the consequential benefits has been favourably considered by the Department of Education where the Petitioner serves and is pending with the Government for final Orders.
2. Rule granted with liberty to apply upon final Orders.

And whereas, in pursuance to the directives of the Hon'ble High Court of Bombay at Goa vide their order dated 18-02-2014 in Writ Petition No. 675 of 2013 and with the approval of the Government and concurrence of Finance (R & C) Department, vide U.O. No. 1480185 dated 24-06-2016, Smt. Cynthia Coelho was granted notional benefits of promotion and consequential benefits viz. Pensionary benefits, in the PB-Rs. 15,600-39,100 + Grade Pay of Rs. 6,600 to the post in the cadre of Deputy Education Officer/Principal, Government Higher Secondary School/Deputy Director, S.I.E./Vocational Education Officer, under the Directorate of Education w.e.f. 29-06-2011 vide Order No. DE/Leg.Cell/W.P./514/2010/1209 dated 12-07-2016. However, the benefits declared to Smt. Cynthia Coelho have been treated as personal to her, subject to authentication of financial implications from the Directorate of Accounts and availability of funds.

And whereas, vide subsequent Addendum No. DE/Leg.Cell/W.R./514/2010/16 dated 27-02-2017 Smt. Cynthia Coelho was allowed to exercise option for fixation of pay under F.R. 22(I)(a)(1) within one month from the date of issue of the said addendum.

And whereas, Smt. Susan Vaz had filed a Contempt Petition No. 18/2012 in the Writ Petition No. 514/2010 in the Hon'ble High Court of Bombay at Goa with the following prayers:-

- (A) This Hon'ble Court be pleased to initiate contempt proceedings against the Respondents and punish them accordingly;
- (B) Such other and further relief that this Hon'ble Court deems fit and proper.

And whereas, the Hon'ble High Court of Bombay at Goa had given the following directions vide Oral Judgement dated 02-08-2017 in Contempt Petition No. 18 of 2012 in Writ Petition No. 514/2010 filed by Mrs. Susan Vaz:-

- (i) The Respondent No. 7 is accordingly directed to hold a fresh GPSC Meeting to consider the Petitioner for the subject promotion in accordance with law uninfluenced by the decision taken in the earlier meetings dated 19-03-2010 and 14-06-2011 within eight weeks from today.
- (ii) Rule is made absolute in the above terms.

And whereas, as the eight weeks time allotted by the Hon'ble High Court of Bombay at Goa for implementation of direction given vide Order dated 02-08-2017 had already expired, the Directorate of Education had filed Misc. Civil Application on 01-11-2017 in the Hon'ble High Court of Bombay at Goa to condone the delay of 36 days in filing the present application and to allow the application for extension of time and to grant a further period of three months to the applicant in the interest of justice.

And, whereas, in pursuance to the directives of the Hon'ble High Court of Bombay at Goa vide Oral Judgment dated 02-08-2017 in Contempt Petition No. 514 of 2010, a proposal was submitted to the GPSC vide letter No. DE/Leg.Cell/W.R./514/2010/149 dated 26-12-2017 for review of DPC proceedings of the meeting held on 14-06-2011 by considering the names of Smt. Cynthia Coelho and Smt. Susan Vaz (Petitioner) for regular promotion in the Cadre of Deputy Education Officer/Principal, Government Higher Secondary School/Deputy Director, S.I.E./Vocational Education Officer against the vacancy dated 01-03-2009.

And whereas, the GPSC vide letter No. COM/II/11/15(1)/2017/1022 dated 19-01-2018 has sent the recommendation of the review DPC which was met on 18-01-2018. The review DPC having assessed the ACRs of Smt. Cynthia Coelho and Smt. Susan Vaz, recommended the name of Smt. Cynthia Coelho for promotion to the post of Deputy Education Officer/Principal, Government

Higher Secondary School/Deputy Director, S.I.E./
/Vocational Education Officer on regular basis.

Now therefore, on the recommendation of the review DPC met on 18-01-2018 as conveyed by the GPSC vide letter No. COM/II/11/15(1)/2017/1022 dated 19-01-2018, the Government is pleased to extend the same benefit of notional promotion and consequential benefit to Smt. Cynthia Coelho as has been granted to her vide Government Order No. DE/Leg.Cell/W.P./514/2010/1209 dated 12-07-2016 and Addendum No. DE/Leg.Cell/W.R./514/2010/16 dated 27-02-2017.
